香港銀行公會專責小組跟進雷曼兄弟事件 於今天舉行首次會議

香港銀行公會(公會)就雷曼兄弟事件成立的專責小組進行了首次會議。會議達成共識，專責小組將協調各會員銀行處理雷曼相關投資產品的事宜，跟進與雷曼清盤人及雷曼產品信託人的聯繫，務求向客戶提供更多有關抵押品及贖回安排的資訊。同時，各會員銀行亦會增加人手以盡快處理事件所引發的個別投訴及查詢。

此外，由於事件涉及多種不同的產品，因此專責小組同意按產品類別分成小組進行詳細討論和分析。該專責小組亦會與監管機構就事件的發展保持溝通，盡力協助受影響的客戶。

Task Force re Lehman Incident (“Incident”) met today

(3 October 2008) The Task Force formed by the Hong Kong Association of Banks (HKAB) to deal with the issues arising from the Lehman Brothers Incident met today for the first time. The meeting has reached a consensus that the Task Force shall facilitate member banks in handling issues related to various Lehman investment products, and following up with Lehman's liquidators and trustees, with a view to passing onto affected customers more information concerning the collateral and redemption arrangement. In parallel, various member banks are also beefing up their manpower to expedite the handling of specific complaints and enquiries arising from the Incident.

Since various investment products are involved in the Incident, the Task Force also agrees to form subgroups to conduct detailed analysis on each category of investment products. The Task Force will also maintain close contact with the regulators on the development of the Incident, in endeavouring to help the affected customers.
