

**Terms and Conditions for Shanghai Commercial Bank Corporate Credit Card /
Business Credit Card Welcome Gift**

1. The promotion period is from 10 December 2018 to 31 December 2019 (the "Promotion Period"), both dates inclusive.
2. Customers must have successfully applied for UnionPay Dual Currency Diamond Corporate Credit Card ("Corporate Credit Card") or VISA / Mastercard Platinum Business Credit Card ("Business Credit Card") ("the Eligible Credit Card") issued by Shanghai Commercial Bank Limited ("the Bank") within the Promotion Period in order to enjoy the welcome gift offer listed below. The welcome gift offer is only available to cardholders who do not hold any Corporate Credit Cards / Business Credit Cards of the Bank in the past 12 months.
