Shanghai Commercial Bank raises HKD Prime Rate and HKD Savings Rate

Hong Kong, 9 May 2023 – Shanghai Commercial Bank (the “Bank”) will raise the HKD Prime rate by 12.5 bp from 5.875% to 6% on 10 May 2023.

The Bank will also raise the HKD Savings rate on the same day from 0.625% to 0.75% for account balance of HKD10,000 or above. Details are as follows:

Balance Tiers (HKD)	Interest Rate
Less than 10,000.00	0%
10,000.00 – 149,999.99	0.75%
150,000.00 – 499,999.99	0.75%
500,000.00 and above	0.75%

Note: Rates shown above are on an annual basis and for indication only.
