

## Shanghai Commercial Bank “Readers Club” Credit Card Welcome Gifts Terms and Conditions

1. The promotion period is from 1 January to 31 December 2022 (the “Promotion Period”), both dates inclusive.
2. New cardholders must have successfully applied for “Readers Club” Platinum / Titanium Credit Card (the “Eligible Credit Card”) (excluding supplementary credit card) issued by Shanghai Commercial Bank Limited (the “Bank”) through the Bank website within the Promotion Period in order to enjoy the welcome gift. The welcome gift are only applicable to principal card applicants who do not hold any credit cards / co-branded credit cards of the Bank in the past 12 months.
3. New cardholders must accumulate spending (“Eligible Transaction”) reaching the designated amount (as set out in the table below) within the first 2 months of new card issuance date (“Spending Period”) in order to be eligible to one of the following welcome gifts:

4. The relevant welcome gift will be credited or sent to eligible new cardholders as follows:
  - 4.1 HK\$300 China Alliance Press Cash Coupon  
The welcome gift notification letter for HK\$300 China Alliance Press Cash Coupon will be sent to new cardholders within 2 months after the Spending Period. Redemption details, including the redemption method, redemption centre address, and redemption deadline will be set out in the welcome gift notification letter.
  - 4.2 HK\$500 Free Spending Credit / 3,000 Asia Miles  
Free Spending Credit / Asia Miles will be credited to the HKD credit card account of the cardholders / Asia Miles Account provided by the cardholders within 2 months after the Spending Period.
5. Eligible spending only includes retail purchase and online purchase but excludes outstanding balance, cash advance, balance transfer amount, purchase and / or recharge prepaid card or e-wallets, purchase of casino chips / traveler's cheque, bill payment, all payments of all credit card charges (e.g. annual fees, finance charges, late charges or interests, etc.), all transactions which are unposted / unauthorized / cancelled / refunded / found to be fraudulent or any other unqualified transactions as determined by the Bank. 6. If new cardholders apply for more than one Eligible Credit Card during the Promotion Period and use more than one Eligible Credit Card to fulfill the welcome offer spending requirement, they are entitled to one welcome gift only.

7. Once welcome gift has been chosen, it cannot be changed. If new cardholders have not indicated his / her choice or indicated more than one choice in the application form, the Bank will automatically set the HK\$500 Free Spending Credit (Gift Code: A0052) as his / her welcome gift.
8. If new cardholders cancel the Eligible Credit Card within 12 months from the date of welcome gift redemption, the Bank will charge an administrative fee of HK\$600 and such fee will be debited from the relevant credit card account without prior notice.
9. All welcome gift information, prices, and photos shown are for reference only. The information provided by suppliers shall prevail.
10. The supplier of the gifts shall be solely responsible for the quality, service and the relevant legal liability of the gift, to which the Bank shall have no legal liability whatsoever.
