

**Shanghai Commercial Bank Credit Card 5% off on big big shop on Friday Terms and Conditions:**

1. The promotion period is from 15 November 2021 to 13 May 2022 (the “Promotion Period”), both dates inclusive.
2. The offer is only applicable to the cardholders (“Cardholders”) of Credit Card / Co-Branded Credit Card / Business Credit Card / UnionPay Dual Currency Diamond Corporate Credit Card (the “Eligible Cards”) issued by Shanghai Commercial Bank Limited (the “Bank”)(applicable for Principal and Supplementary Card). Cardholders are required to settle the relevant payment with the Eligible Card in order to enjoy the offer.
