Except so far as otherwise expressly stated, the transfer of this Documentary Credit is subject to the latest version of the Uniform Customs and Practice for Documentary Credits, International Chamber of Commerce, Paris, France, which is in effect on the date of issue.

All corresponding bank charges are for account of second beneficiary. If the second beneficiary refuses to pay the charges, please debit the same to our account.
